SHAEFFER: *Well we had to get it on the recorder and stuff I mean this is a...a...a very serious incident.*

VINSON: *I know it...who...who is responsible? I mean we lost somebody out here. That possibly could be my son don't y'all even give a damn while I'm sitting in here?*

SHAEFFER: *Did you get...happen to see the car?*

VINSON: *The...man is that all...that's all I can say is that...is we done with my statement?*
